Acceptable Identification for Library Membership Applications

To join Goulburn Mulwaree Library, applicants must provide ID as proof of name & current address.

The following forms of ID will be accepted:

- Current driver's licence
- Council rates or water notice
- Residential tenancy agreement
- Commonwealth or State electoral card
- NSW photo ID card
- Centrelink pensioner, concession, or healthcare card
- Electricity, gas, or telephone account
- Bank statement

Applicants under 18 years of age must have a parent or guardian apply on their behalf. The parent or guardian must provide their ID, as listed above.
